During the week from September 26th to October 2nd, 2011, Masset RCMP responded to 27 calls for service. Some of these were:

- On September 26th at 1100hrs, Masset RCMP responded to a possible explosive cartridge located on Tow Hill beach. Police determined the item was a metal buoy that was harmless
- On September 27th at 1830hrs, Masset RCMP received a report of an overturned boat in the 1400blk of Delkatla Rd. Police attended and determined it was actually a tent that had been abandoned. The tent was removed.
- On September 28th at 0400hrs, Masset RCMP received a report of a possible impaired in Old Masset. Patrols were negative to locate the vehicle.
